Those entities are free to sign on independent of one another.

- **(I)** Indicates that some document indicating the entity carries insurance has been received in accordance with Page 12 of the Agreement.
- **(V)** Indicates that a signature has been verbally communicated but nothing is on file.
- **JUST THE NAME** of an entity means that there is a signature page (Page 15) signed by the entity in our file but no other documents have been received.
