

ANNEX G TO HURRICANE PLAN
HURRICANE EVACUATION FUELING AND REFUELING OPERATIONS

I. INTRODUCTION

- A. During evacuations for a hurricane, significant portions of the population will be displaced and requested/ordered to evacuate.
- B. A number of evacuees will leave their points of origin in vehicles with insufficient quantities of fuel to reach their destination and will need to refuel while en-route.
- C. Because of increased fuel demand by evacuees, large-scale evacuations blocking access routes, and the closing of supply terminals/ports due to impending hurricane landfall, fuel stops/vendors may experience fuel supply shortages before, during, and after major evacuations.
- D. Such shortages may result in point of sale rationing or the closing of due to lack of fuel. These shortages or closures may impact the public's ability to obtain fuel while evacuating.

II. PURPOSE

- A. Outline a basic protocol for fuel supply and re-supply to selected fuel stops on or near hurricane evacuation routes before, during, and immediately after a major hurricane evacuation.
- B. Ensure fuel is available to the evacuating public at selected fuel stops consistent with safety and commercial ability to re-supply.

III. CONCEPT OF OPERATIONS

- A. The Office of Regulatory Staff (ORS) is the lead State Agency for pre-event planning and coordination of the Hurricane Evacuation Fueling and Refueling plan.
- B. Emergency Support Function (ESF)-12 (Energy) is the lead ESF for coordinating and assisting in the execution of the Hurricane Evacuation Fueling and Refueling Plan for the general evacuee population, in accordance with Attachment F of the ESF 12 SOP.
- C. SEOC Operations will maintain overall oversight of the evacuation operations to include the Fueling and Refueling Plan.
- D. This plan therefore will only be implemented as required or directed.
 - 1. The State of SC will implement this plan wholly or in part in response to a hurricane evacuation, and/or as coordinated between SCEMD, ESF-12 (Energy), and the affected suppliers/vendors.
- E. Actions taken to support execution of this plan

1. State of South Carolina:
 - Monitor the storm, evacuation actions and landfall timing
 - Coordinate execution and termination dates/times, areas and specific fuel stops for priority fueling operations with participating entities
 - Monitor plan execution
 - Assist in the logistic and coordination of fueling/refueling of fuel stops with the commercial motor fuel suppliers
2. Participating commercial motor fuel suppliers, petroleum corporations, suppliers, transporters and vendors:
 - Respond to ESF 12 Energy requests to provide priority fuel stop information
 - Coordinate Fueling Services in accordance with Attachment F of the ESF 12 SOP
 - Coordinate execution and termination dates/times, areas and specific fuel stops for priority fueling operations with the State of South Carolina
 - Manage and dispatch fuel loads
 - Determine fuel destinations
 - Monitor inventory levels as provided by participating stations
 - Coordinate fuel allocations to maintain priority fuel stop supplies

F. Priority for Sites and Fueling

1. Prior to plan implementation, ESF-12 (Energy), in coordination with the SEOC, ESF-1 (Transportation), ESF-16 (Emergency Traffic Management) and affected fuel stop owners, will establish priority fuel stop sites and order of priority for maintaining fuel supply.
2. ESF-12 (Energy), in coordination with the fuel stop owner and SEOC Operations, may modify the site and fueling prioritization during execution as conditions require.

G. Locations/Sites For Priority Fueling Operations

1. As agreed between the SCEMD, ESF-12 (Energy) and applicable fuel stop owner's representative(s) and vendors, locations/sites along pre-determined evacuation routes will receive fuel shipments during hurricane evacuation operations.
2. Attachment 1 (Potential Hurricane Pre-Storm Fueling Stations) of this document and contain a listing of fuel stops that would potentially be utilized in the event of an evacuation. The listing is neither complete nor exclusive.
3. The selection of stations will be done in coordination with the vendors, ESF-12 and SCEMD, and will be based on the requirements of the situation and the evacuation.
4. Additions or deletions of sites must be coordinated between SCEMD, ESF-12 (Energy) and the appropriate suppliers or vendors.

H. Implementation

1. At OPGON 3 (approximately 36 hours prior to potential evacuation), ESF-12 (Energy) will alert fuel stop owner representatives of impending priority fuel operation and provide anticipated area(s) identified for priority fueling.
2. When the SEOC moves to OPGON 2 (approximately 24 hours prior to evacuation), SCEMD will determine the scope of the potential evacuation and provide specific areas within which the operation will commence. ESF-12 (Energy) will communicate and coordinate this information with the fuel stop owner representatives.
3. ESF-12 (Energy) will coordinate the implementation, timing of the operation, and termination with all affected fuel stop owners.
4. ESF-12 (Energy) will monitor the execution of the operation and provide updates to SEOC operations as needed until the operation is terminated.
5. Based on current and/or anticipated fuel demand, ESF-12 (Energy) and fuel stop owner representatives will coordinate to maintain fuel availability/inventory levels at the designated fuel stops, to include the coordination of fuel/refuel operations to maintain desired fuel availability.
6. SEOC Operations, in coordination with ESF-12 (Energy) will determine the actual termination date/time; which will be a function of reduced evacuation flow, reduced fuel demand, or when sustained winds are observed in excess of 39 mph.

I. Transportation and Traffic Management

1. To support the fuel stops selected for priority supply, commercial motor fuel supplier/vendor bulk transport will use existing, pre-planned delivery routes until evacuation conditions require alternate routes to fuel stops.
2. When requested by fuel stop owner representatives through ESF-12 (Energy), ESF-1 (Transportation) and ESF-16 (Emergency Traffic Management) will determine appropriate primary and/or alternate transportation routes to and from fuel supply and delivery points.
3. ESF-16 (Emergency Traffic Management) will prioritize the movement of bulk fuel trucks across evacuation routes as required at Traffic Control Points (TCP).
4. Law enforcement escort of bulk transport vehicles will not take place unless authorized by SEOC Operations and coordinated through ESF-13 (Law Enforcement).
5. ESF-16 will monitor evacuation operations and prioritize fuel transport as required.

J. Pricing

1. Pricing of motor fuels is not regulated by this plan.
2. Pricing during declared emergencies is subject to the provisions of Section 39-5-145 of the Code of South Carolina.

K. Reentry, Post-Landfall and Recovery

1. Priority fueling operations are not planned for execution during the Reentry Phase of response unless authorized by State officials and after coordination with commercial motor fuel suppliers and vendors.
2. Depending on scope and scale of the disaster impact, post-landfall and recovery actions may include commercial vendors supplying fuel to selected fuel stops within the impacted areas. These stations could act as jurisdictional Public Safety Emergency Fueling Points and/or fueling points for the general public.
3. Coordination for commercial fuel supplies for government-owned vehicles is done through SC Department of Transportation (SCDOT) and SC Department of Education (SCDE).
4. Location and accessibility to stations, and availability of fuel and power (either commercial or generator) are all considerations that will be coordinated between the ESF-12 (Energy), SEOC Operations and

commercial suppliers and vendors before establishing the emergency fueling points.

L. Operational Direction and Control

1. SEOC Operations will maintain direction, control and oversight over all State-level responding ESFs/agencies.
2. Fuel suppliers, fuel stop owners and vendors will maintain direction and control of personnel and equipment normally under their control.

M. Communications

1. All entities will use their normal communications methods and modes. As this operation will take place prior to landfall, all normal communications means should be available.
2. No specialized communications assets, owned or operated by SCEMD (satellite telephone/radio, etc.) will be employed by State-level agencies or ESFs unless authorized by SEOC Operations.

IV. ORGANIZATION AND ASSIGNMENT OF RESPONSIBILITIES

A. ESF

1. ESF-1 (Transportation)

Provide route planning assistance as requested during priority fueling operations.

2. ESF-12 (Energy)

a. Serve as the primary liaison between the State of South Carolina and the fuel stop owners for coordinating the execution of this protocol.

b. Response

(1) Include fuel stop owner representatives on ESF-12 (Energy) staff when responding to a major hurricane (Category 3 or higher).

(2) Coordinate/communicate with SEOC Operations, fuel stop owner representatives, and vendors regarding timing for plan execution, and areas/specific locations to receive priority for fuel.

(a) At OPCON 3 (approximately 36 hours prior to evacuation):

- Alert fuel stop owners of impending priority fuel operation.
 - Provide anticipated area(s) identified for priority fueling.
- (b) At OPCON 2 (approximately 24 hours from evacuation):
- Reconfirm identified priority fueling areas
 - Notify fuel stop owners to begin priority fueling operation.
- (3) Coordinate the implementation, timing of the operation, and termination with all affected fuel stop owners. Priority fueling operation will terminate not later than 4 hours prior to the onset of Tropical Storm Force Winds (39 mph) anywhere on the coast of South Carolina.
- (4) Monitor the execution of the operation and provide updates to SEOC operations.
- (5) As required, assist fuel stop owner representatives in coordinating for travel priority through/across evacuation routes and for law enforcement escort for bulk fuel re-supply as requested and as authorized by SEOC Operations.
- (6) Coordinate and assist in route planning, re-planning, and other plan immediate needs with SEOC Operations, appropriate ESFs and fuel suppliers/vendors.
- c. Recovery
- (1) If authorized, coordinate the restart of priority fueling operations to assist reentry traffic movement.
- (2) As necessary, coordinate post-landfall priority fueling operations at selected locations in the impacted areas and assist vendors with access, power generation, fueling site security and other needs.
- (3) If required, coordinate establishment of county/municipal public safety fueling points with SCDOT.
- (4) In coordination with suppliers and vendors, continue priority public fueling operations and/or public safety fueling operations as required/ authorized.

3. ESF-13 (Law Enforcement)
 - a. Coordinate law enforcement escort for bulk fuel re-supply as requested by ESF-12 (Energy) and as authorized by SEOC Operations.
 - b. Coordinate site security for refueling sites as requested by ESF-12 (Energy) and as necessary.
 4. ESF-16 (Emergency Traffic Management)
 - a. Assist ESF-1 (Transportation) with route planning during priority fueling operations and with primary and secondary route development.
 - b. Prioritize the movement of bulk fuel trucks across evacuation routes as required at Traffic Control Points (TCP) and prioritize bulk fuel shipments for timely travel to/from selected priority fuel sites.
- B. State Agencies and Support Organizations
1. South Carolina Emergency Management Division
 - a. Analyze storm and potential impact information, determine areas requiring fueling operations, and operation execution date/time.
 - b. Authorize fueling operation to begin, monitor fueling operation; and update areas/locations requiring fuel operations as storm and/or evacuation conditions dictate.
 - c. Modify fueling areas, monitor evacuation and landfall timing, and coordinate actions and information with ESF-12.
 - d. Coordinate with ESF-12 (Energy) fueling termination date/time, and terminate priority fueling operation not later than 4 hours prior to the onset of Tropical Storm Force Winds (39 MPH) anywhere on the coast of South Carolina.
 - e. Determine need for county/municipal public safety fueling points and coordinate reentry/post-landfall/recovery fueling operations for the general public through ESF-12 (Energy) as necessary.
 2. South Carolina Office of Regulatory Staff
 - a. Serve as the primary liaison between the State of South Carolina, fuel stop owners for pre-event planning and coordination.

- b. Annually review and update this plan to include coordinating with current and/or identifying and coordinating with new priority fuel stops to participate in this plan. Maintain this protocol in coordination with participating agencies, suppliers, and vendors.
 - c. Establish an emergency contact list that includes telephone and e-mail address for each person/company listed. Review and update this list annually.
 - d. In coordination with SCDOT, SCDPS and the fuel stop owners, pre-plan primary and alternate routes for fuel delivery to pre-identified filling stations.
3. South Carolina Department of Transportation
- a. During the Preparation Phase, assist ESF-12 (Energy) in pre-planning primary and alternate routes for fuel delivery to pre-identified fuel stops.
 - b. Provide commercial fuel supplies for government-owned vehicles in accordance with Annex 1 (Post-Disaster Refueling Operations for Emergency Response Vehicles/Equipment) to Attachment A (South Carolina Logistics Plan) to the SCEOP, or as coordinated/required.
4. South Carolina Department of Education
- Provide commercial fuel supplies for government-owned vehicles in accordance with Annex 1 (Post-Disaster Refueling Operations for Emergency Response Vehicles/Equipment) to Attachment A (South Carolina Logistics Plan) to the SCEOP, or as coordinated/required.
5. South Carolina Department of Public Safety
- During the Preparation Phase, assist ORS and SCDOT in pre-planning primary and alternate routes for fuel delivery to pre-identified fuel stops.
6. Fuel Stop Owner Representatives
- a. Coordinate with ORS regarding plan update/modification.
 - b. Coordinate with ORS the pre-planning of primary and alternate routes for fuel delivery to pre-identified filling stations.
 - c. Coordination execution with ESF-12 (Energy).

- d. Coordinate with ESF-12 (Energy) regarding protocol execution and termination; prior to and during evacuation operations, schedules, and dispatches
- e. Monitor priority fuel shipments to selected fuel outlets.
- f. Monitor fuel availability at the selected fuel outlets, maintain sufficient fuel inventory to enable public refueling during major evacuations, and coordinate with fuel outlets regarding fuel shipments, schedules, stock levels, etc., to ascertain refuel needs.
