

**ANNEX J TO HURRICANE PLAN**  
**MEDICAL NEEDS SHELTER MANAGEMENT**

---

**I. GENERAL**

- A. Medical Needs Shelters (MNS) are provided for evacuees requiring medical attention and their caregiver.
- B. All licensed healthcare facilities and home health agencies are required by license agreement to develop emergency plans for their clients that do not include Medical Needs Shelters as their emergency destination.

**II. MEDICAL NEEDS SHELTERS**

- A. See Annex 6 (Mass Care) for Lead and Support Agency roles and responsibilities for MNS as well as general sheltering criteria.

- B. Opening of MNSs

- 1. DHEC will open and operate Medical Needs Shelters in coordination with the ESF 6 Mass Care and local emergency management where needs have been identified.

- Depending on scale and scope of a disaster and identified need, available co-located sites should be opened first and prior to any “stand alone” facilities.

- 2. The trigger for opening of the MNS will depend on if there is an evacuation ordered by the Governor, and persons are identified as meeting MNS criteria.

- a. In Coordination With A Hurricane Evacuation

- (1) At the beginning of the evacuation, ESF-6 will coordinate with DHEC to open SMNSs to support the evacuation plan and respond to the evacuation of the coastal areas.

- (2) After tropical force winds have passed through the areas, DHEC will open additional MNSs as persons are identified as meeting the criteria for a MNS shelter. The opening of MNS will be done in coordination with county emergency management to support the sheltering needs of the local communities.

- b. In the event of a hurricane without an evacuation order, DHEC will open MNS once someone has been identified as meeting the criteria for a SMNS shelter. SCDHEC will open and close shelters in coordination with County Emergency Management to meet the sheltering needs of the local impacted areas.

- C. Closing of MNSs

1. A MNS will not close until all shelter clients can return home or relocate to a suitable alternate location.
  2. DHEC will coordinate the closing of MNSs with local emergency management and with ESF-6 (Mass Care).
  3. For a co-located shelter, closing of an MNS will be coordinated with local ESF 6 partners, including local and state DHEC staff.
- D. DHEC has pre-coordinated the following facilities for use as MNSs in support of the Hurricane Evacuation Plan.
1. These locations are subject to change with/without notice.
  2. Shelter locations and capacities will be maintained on Palmetto.
  3. As co-located facilities are identified, they will be added to the following list and be designated as a co-locate facility.
