ANNEX H TO HURRICANE PLAN GENERAL POPULATION SHELTER MANAGEMENT

I. GENERAL

- A. General population shelter management includes:
 - Estimating the number of evacuees who may require shelter
 - Planning shelter space
 - Surveying facilities on a recurring basis
 - Planning, anticipating and coordinating staffing
 - Coordinating resources
 - Providing sustainment and logistical support
 - Addressing functional or unique individual medical needs
 - Consistent and accurate reporting and communication
 - Identifying and providing public information on pet shelter facilities within reasonable proximity to each shelter
 - Coordinating shelter openings and closing in close coordination with State, county, and local officials
- B. Hurricane evacuation shelter requirements are calculated using a percentage of the population in the evacuation zones. Hurricane Region counties identify facilities with adequate space to fulfill these sheltering requirements.
- C. Identified facilities must be immediately accessible and under the purview of government authority to open, operate, and close.
- D. Written agreements may be in place between county and government/non-government entities.
- E. Counties (and municipalities) have legal responsibility for public health and safety in shelters under South Carolina law.
 - 1. Sheltering survivors falls under emergency protective measures, which must "Eliminate or lessen immediate threats to life, public health or safety; or eliminate or lessen immediate threats of significant additional damage to improved public or private property..." (44 CFR §206.225 (a)(3))
 - 2. The South Carolina Code of Laws (Section 25-1-450(2)(c)) states that counties (and municipalities) are responsible for developing and implementing a shelter/relocation plan", therefore Counties would be the eligible applicant for Public Assistance.

- a. This responsibility would not extend to school districts, as these entities would not have legal responsibility for sheltering disaster survivors. Therefore, school districts would not be eligible for direct reimbursement for sheltering activities through the FEMA Public Assistance program. Reimbursement for such activities would be eligible for the legally responsible applicant (County).
- b. School Districts in the State of South Carolina are independent bodies politic as identified in South Carolina Code of Laws (Section 59-17-10).
- 3. Any work claimed for Public Assistance must be the legal responsibility of the eligible applicant. (44 CFR §206.223 (a)(3))

II. CONCEPT OF OPERATIONS

- A. ESF-6 (Mass Care) is the lead Emergency Support Function (ESF) for managing the general population and Medical Equipment Power Shelter plans and execution.
- B. SC Department of Social Services (DSS) is the lead State agency for managing the State general population shelter plan and general population shelter execution.
- C. The American Red Cross (Red Cross), as a support agency to ESF-6, surveys, opens, manages, operates, transitions, and closes Red Cross managed shelters in coordination with DSS and County Emergency Management based on Red Cross resourcing capabilities and commitments.

The American Red Cross will not open, operate, staff, manage, resource, or support a shelter in an evacuation or surge zone, or a shelter that does not comply with the American Red Cross Hurricane Evacuation Shelter Selection Standards.

- D. Some shelters may also be managed by other partners. Partners may include DSS, local CERT, religious organizations, non-profits, and others.
- E. SC Department of Public Health is the lead state agency for managing the State Medical Equipment Power Shelter plan and Medical Equipment Power Shelter execution.
- F. General Population Shelter coordination
 - 1. County Emergency Management, SCEMD, County and State ESF-6, and the Red Cross coordinate General Population shelter locations.
 - 2. Shelter staffing management, reporting, and communications are coordinated between the DSS, DPH, and the Red Cross.

G. General Population Shelter Identification

- 1. To coordinate shelter openings, ESF-6, SCEMD, and the counties identify public general population shelters before the beginning of hurricane season.
- 2. Evacuation Support shelters are identified in sets designed for simultaneous opening. These shelters are arranged throughout the northern, central, and southern hurricane regions, and generally are larger capacity shelters.
- 3. Local Support Shelters are shelters that can open at the request of the counties. These shelters may operate with or without ARC support and may be located throughout the state.

H. Shelter Survey Process

- 1. The Red Cross surveys general population shelters to determine capacity. Shelters should be updated for POC's and any changes yearly. Shelters should be surveyed based on the American Red Cross operational process and policy.
- 2. All Hurricane Shelters in all counties are surveyed per the American Red Cross Hurricane Evacuation Shelter Selection Standards. All hurricane shelters follow these standards for selection.

I. Opening of General Population Shelters

- 1. Pre-storm, the Red Cross may support up to 22 shelters. Additional Red Cross shelter staff and supplies may be brought in post-landfall as needed and as available.
- 2. Up to 22 Evacuation Support shelters will open to support the evacuating population. The initial 22 shelters will be coordinated between State ESF-6 and County Emergency Management from the pre-determined list of Evacuation Support Shelters.
- 3. The number of Evacuation Support Shelters that will open will be determined by the population in the evacuation order.
- 4. The list of Evacuation Support Shelters designated to open will be shared during the county coordination calls. ESF-6 and the counties will agree on the list 24 hours before the evacuation begins.
- 5. Evacuation Support Shelters will open at the start of the Evacuation.
- 6. Additional Local Support Shelters may be requested and/or operated by the counties as needed.

- 7. Local Support Shelters can open until the arrival of tropical storm force winds. They may also open post storm.
- 8. Neither Evacuation Support Shelters nor Local Support Shelter are limited to residents living in the evacuation zones.
- 9. ESF-6 (Mass Care), in coordination with SCEMD and county emergency management, has the authority to adjust the openings of shelters and the coordination of opening to meet the requirements of the situation and the requirements of the evacuation.
- 10. Additional shelters within the state may open as shelters begin to reach 75% capacity.

J. General Shelter Operations

- 1. Red Cross managed shelters are open to the public without discrimination of any kind.
- 2. Red Cross will not deter evacuees from leaving the shelter; however, authority to authorize and allow residents to return to an area resides with the local government.
- 3. Red Cross will keep shelters open or on standby based on identified need and operational policy and procedure.

K. Closing of General Population Shelters

- 1. The decision to close shelters is based on many factors including the number of evacuees in the shelter, returning destination of the evacuees, location of other nearby shelters, available transportation, and housing options.
- 2. Before shelters are closed, the County Emergency Management Director and the SEOC Operations will determine that a threat no longer exists.
- 3. The identification and recommendation on which shelters to close or consolidate are based on coordination between the SEOC, County Emergency Management, and County and State ESF-6 (Mass Care) in conjunction with the Red Cross Disaster Relief Operational Headquarters (DRO HQ).
- 4. The Red Cross DRO HQ will notify ESF-6 (Mass Care) when shelters are officially closed. ESF-6 (Mass Care) in conjunction with the SEOC Public Information Officer will inform the SEOC staff and Public Information Phone System (PIPS) Manager once a shelter is closed.

5. This process does not apply to Medical Equipment Power Shelters (MEPS) (see Annex I – Medical Equipment Power Shelter and Medical Evacuation Management) or shelters managed by other agencies or organizations.

L. Public Announcement of General Population Shelter Openings/Closings

- 1. ESF-15 (Public Information) will coordinate public announcements regarding evacuation and local support shelters and publish the information by via multiple means and sources, including local broadcasts, Joint Information Center releases, the Public Information Phone System (PIPS) and the Red Cross.
- 2. The public announcement will include each shelter name, location, the address, associated route and exit, and shelter(s) opening time.
- 3. Open shelters can be found at redcross.org and https://www.scemd.org/stay-informed/emergency-shelters/.
- 4. Shelters may open before the announced time. Once a shelter is reported at 90% capacity or above, ESF-6 (Mass Care) will coordinate with ESF-15 (Public Information) to no longer include the shelter in public announcements as "open."
- 5. ESF-15 (Public Information) will provide announcements to major media outlets from State and County EOCs.

M. Public Sheltering Requirements

- 1. Sheltering Estimates
 - a. To plan shelter space for evacuees, the population for each hurricane evacuation zone expected to seek public shelter was calculated. Sheltering numbers from past hurricanes and responses from the hurricane behavioral survey were used to estimate the percentage of the population living in evacuation zones that would be likely to seek public shelter. 2%, 3%, and 5% were used as planning factors.
 - b. Compliance rates were used as an additional planning factor. 25%, 50%, 75%, and 100% compliance rates were used.
 - c. The total population requiring sheltering in the Hurricane Regions is continually changing. This change is due to the increasing coastal population.
- 2. Shelter Requirements

- a. Planning considerations for hurricane shelters involve several factors and require close coordination with the local officials and/or emergency management responsible for public safety. Technical information contained in hurricane evacuation studies, storm surge, flood mapping and other data can be used to help make informed decisions about the suitability of shelters. Reference the American Red Cross Hurricane Evacuation Shelter Selection Standards.
- b. The forecasted impacts and severity of an approaching hurricane may reduce the number of available shelters in the affected counties.
- c. Emergency capacity is determined using 20 sq ft/person for hurricane evacuation shelters.
- d. For shelter operation extending post storm 40 sq. ft. per person is allocated and a population shift may be required.
- N. Medical Equipment Power Shelter and Medical Evacuations Management (See Annex I)
